Know This!



417 State and Shared Agency locations remain in Scope; 345 (82%) are completed to date. 72 remain to transform. 113 Authorized Users are in scope; 96 (85%) are completed to date. 17 remain to transform.

Agency specific detail reports were distributed to Agency SPOCs the week of July 1, and a high level summary report is posted to BadgerNet customer portal <https://det.wi.gov/Pages/BadgerNet.aspx>

- A twelve (12) month minimum commitment is required for any circuit order or a termination penalty will apply which will be calculated at 50% of the price over the remaining Term.
- Customers wishing to cancel a BadgerNet order prior to install of the service, may be charged any costs incurred by the vendor during the processing of the order up to date of cancellation.

Transformations to the new BadgerNet Network were targeted for completion by June 30, 2018, carryover has occurred due to: telco dependencies, and intervals to complete approved remediations for customers with special construction.

As transformation to the BadgerNet network nears completion, BadgerNet is currently operationalized as a service. Customers should open a BadgerNet Service Request for new orders.

August 15: Customers selecting alternatives to BadgerNet must be transitioned; AT&T will be discontinuing service on BCN and/or charging remaining customers.

Top Concerns

- Agencies selecting alternatives to BadgerNet meeting contractual deadline of August 15th when AT&T plans to commence disconnects from the BCN network.
